TITLE: RESOLUTION AUTHORIZING EXECUTION OF AGREEMENT PROVIDING FOR AMENDMENT TO SETTLEMENT AGREEMENT PREVIOUSLY ENTERED INTO BY AND BETWEENT HE BOROUGH OF NORTHVALE AND FAIR SHARE HOUSING CENTER

WHEREAS, on March 10, 2015, the New Jersey Supreme Court issued its decision in In re N.J.A.C. 5:96 and 5:97, 221 N.J. 1 (2015). In that decision, the New Jersey Supreme Court transferred primary jurisdiction over affordable housing matters from the New Jersey Council on Affordable Housing ("COAH") to the New Jersey Superior Court and established a transitional process for municipalities like the Borough of Northvale to file declaratory judgment actions seeking to declare their Housing Element and Fair Share Plans to be constitutionally compliant and seeking similar protections to what they would have received if they had continued to proceed before COAH; and

WHEREAS, the Borough of Northvale filed a declaratory judgment action on July 6, 2015 (the "Action"), petitioning the Superior Court of New Jersey, Law Division, Bergen County Vicinage (the "Court") for a judgment of compliance with the Mount Laurel doctrine and Fair Housing Act of 1985, N.J.S.A. 52:27D-301 et seq., in accordance with In re N.J.A.C. 5:96 and 5:97, 221 N.J. 1 (2015); and

WHEREAS, the Borough of Northvale entered into a Settlement Agreement with the Fair Share Housing Center arising out of the Action (the "Settlement Agreement") that identified the Borough of Northvale's affordable housing obligation and indication of how the Borough would satisfy that affordable housing obligation; and

WHEREAS, the Borough Council of the Borough of Northvale, by Resolution adopted February 14, 2018, approved the Settlement Agreement; and

WHEREAS, subsequent to the execution of the Settlement Agreement, the Borough and FSHC acknowledged and agreed that it would be acceptable for the Borough to address a portion of its outstanding 50-unit Prior Round unmet need obligation by replacing the potential development of a six (6) unit affordable housing project on Borough owned property with the creation of an overlay zone conditionally permitting multi-family residential development within an area in the Borough which consists of the entirety of the Professional Office Zone and a portion of the C-1 (Commercial) Zone and which area is more fully identified on a map dated February 2019; and

WHEREAS, the Borough and FSHC have acknowledged and agreed that this change requires the amendment of the Settlement Agreement in accordance with the terms and conditions set forth in the agreement providing for Amendment to Settlement Agreement (the "Amending Agreement) in the form annexed hereto as Attachment "A"; and

WHEREAS, it is in the best interests of the Borough to enter into the Amending Agreement.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Northvale, County of Bergen and State of New Jersey, that the Mayor shall be and hereby is authorized to execute the Amending Agreement in the form annexed hereto as Attachment "A"; and

BE IT FURTHER RESOLVED that the Mayor and Council of the Borough of Northvale, County of Bergen and State of New Jersey, hereby authorizes and directs the

Borough Attorney to take any and all actions as are necessary and/or required by the Amending Agreement and/or the Settlement Agreement amended thereby.

Section 2. The compensation of Special Police and School Crossing Guards shall be as follows:

School Crossing Guards - per hour \$ 21.93

Section 3. In addition to the compensation set forth in Section 1, each full time employee of the Borough of Northvale shall receive longevity pay as follows:

2% of the base annual pay after 5 years of service 4% of the base annual pay after 9 years of service 6% of the base annual pay after 13 years of service

8% of the base annual pay after 17 years of service 10% of the base annual pay after 21 years of service

If an employee reaches a higher plateau of longevity entitlement at any time during the calendar year, then said employee shall be entitled to receive the full value of the higher plateau in that calendar year.

Non-contractual employees hired after January 1, 1993 are not eligible for longevity.

Section 4. Time in excess of forty (40) hours per week for all full time employees is to be paid at the rate of time and one-half excluding all statutory appointments.

Section 5. All full time Borough employees and School Crossing Guards shall be paid bi-weekly, or as determined by resolution of the Mayor and Council.

Section 6. Sick leave policies for all employees other than D.P.W. Contract and Police Contract employees are in accordance with Administrative Rules, Regulations and Practices.

Section 7. All ordinances or parts of ordinances inconsistent herewith are repealed.

Section 8. Salaries, wages and compensation herein set forth shall be retroactive to January 1, 2019.

Section 9. This ordinance shall take effect immediately after passage and publication according to law.
