RESOLUTION #2024-149

TITLE: RESOLUTION APPROVING THE 2023 AUDIT

WHEREAS, the Annual Report of Audit for the year 2023 has been filed by a Registered Municipal Accountant with the Municipal Clerk as per the requirements of N.J.S. 40A:5-6, and a copy has been received by each member of the governing body; and

WHEREAS, the Local Finance Board of the State of New Jersey is authorized to prescribe reports pertaining to the local fiscal affairs, as per R. S. 52:27BB-34; and

WHEREAS, the Local Finance Board has promulgated a regulation requiring that the governing body of each municipality shall by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled:

and

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled:

General Comments
Recommendations

as evidenced by the group affidavit form of the governing body; and



WHEREAS, such resolution of certification shall be adopted by the governing body no later than forty-five days after the receipt of the annual audit, as per the regulations of the Local Finance Board; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52 - to wit:

R.S. 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

NOW, THEREFORE BE IT RESOLVED, that the governing body of the Borough of Northvale hereby states that it has complied with the promulgation of the Local Finance Board of the State of New Jersey dated July 30, 1968, and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

There was no old business to discuss at this time.

NEW BUSINESS

There was no new business to discuss at this time.

MAYOR & COUNCIL REPORTS

Council President McMorrow – Police Department responded to 707 calls during the month of November – 116 selective traffic enforcement details, 112 traffic stops, 25 burglar alarms, and 17 motor vehicle crashes. There was one arrest of a 49 year old from Paterson of one count of



possession of drug paraphernalia. The Preschoolers and their families enjoyed participating in the tree lighting. It has become a wonderful tradition now for the Northvale Preschool. Often times many young families first exposure to town events is through the Preschool. We love the opportunity to participate in these community events. Registration for 2025-2026 is open. We anticipate another year of full enrollment. Ambulance Corps responded to a total of 22 calls for the month of November. There were 10 to Northvale, 2 Rockleigh residential, 2 Jewish Home in Rockleigh, 1 Norwood, 2 Harrington Park, 3 Closter, 1 Demarest, and 1 Alpine. A big thank you to Iris Fallon and Kevin Trainor for an incredible Tree Lighting. Thank you to the DPW for making Hogans Northvale's own Hallmark Movie. It was an absolutely great night! Thank you to the Police Department, NVAC, Preschool, Northvale Public Schools, Boy & Girl Scouts, Shoprite, Starbucks, Northern Valley Chamber of Commerce, St Anthony's and Radiant Light Church, D'Ercoles Farm, and Cleatus Farm for your participation, donations, and attendance at the event. It was a great kick off to the holiday season and really reminded me of why I get involved, it is the community that comes together for these great moments. The Battle of Bulbs lighting competition deadline has been extended until tomorrow, December 12th at 5 pm. Please enter your festively decorated house into the competition. Judging will take place on Friday, December 20th.

Councilman Bakalian – there were no meetings in November for the Planning/Zoning Board. Building Department issued a total of 8 permits and updated 1 permit in the month of November. The Building Department is using a new software, SDL, which understates the fee collection for November because the last week was not included. The old software terminated on November 25th. Fees collected for November were \$17,366 as compared to November of 2023 which were \$11,835. The year to date fees collected are \$26,218 more than last year. The Chamber of Commerce is discussing expanding their involvement in community events and getting involved at NVOT with the business student clubs. Thank you to everyone for a great tree lighting.

Councilman Menafra – Fire Department statistics for the month of November are – 16 emergency calls totaling 127 man hours which included 5 fire alarms, 2 utility, 1 smoke condition, 1 structural fire, and 2 non-structural fires. There were 20 non-emergency calls totaling 378.25 man hours including 2 company drills. The VoIP phones and service installation is tentatively scheduled for January 2025. Fire Prevention performed 26 inspections and 9 re-inspections for the month of November. Northvale Board of Education held their regular meeting on November 21st. Mr. Pinajian reported that the newly opened Reset Center is thriving and providing opportunities for various students to participate in peer leadership roles. A detailed report regarding the Reset Center is expected to be presented at an upcoming board meeting in early 2025. Some building and grounds updates – softball and baseball field renovations are in progress, the blacktop in the rear of the school has been replaced, and the roof above the All Purpose Room is being corrected for leaks. More than 30 school policies and over a dozen school regulations were updated for compliance with upcoming QSAC evaluations. The next regular meeting is scheduled for December 19th at 6:30 pm in the All Purpose Room. Northern Valley Board of Education held their last meeting on November 18th at 7:30 pm. There was a presentation of awards for National Merit commended students. The Superintendent congratulated re-elected and newly elected school board members from Old Tappan, Norwood, and Closter. The school held the 2nd annual AI summit on December 9th with keynote speakers Ron Chandler from Apple and Arthur Chien, author of GPT Zero and AI detection tool. The Game Changer program was kicked off, which allows students to participate in recreational sports with Northern Valley Central students. The Superintendent recommended rejecting all bids for the NVOT Team Room renovation project since they came in over budget. The NVOT Girls Volleyball team finished a perfect season with a 25-0 record. The NVOT Football team won their second Group 3 state title, besting Mainland 28-16 at Rutgers. Mr. Spatz did a presentation on college counseling and process. Nationwide, college enrollment and attendance is decreasing. More than 80% of students were admitted to and attended one of their top choice schools. In a student completed survey, 94% of responders were satisfied with the high school's process and counseling program. NVOT held a Veteran's service on November 12th, career day on November 15th, and school play, The Witch's Princess, from November 21st to 23rd. The performance was great. Next meeting is scheduled for December 16th at 7:30 pm at the NVD Media Center.



Councilman Sokoloski – Board of Health reorganization meeting will be held on January 9th at 7:00 pm. Requested grants pending total \$1,844,459.79 which is down slightly. We are now submitting a CDBG grant for ADA restrooms at the firehouse for \$150,000. Grants awarded so far total \$1,595,802.

Councilwoman Fernandez – The Library's next meeting is December 18th at 6:30 pm. The Library had an art show on December 10th which was sponsored by Paint Smile Sip. They will be having a movie matinee on December 19th at 12:30 pm. The Library will be closed Christmas Eve and Christmas Day.

Councilman Mattessich – DPW has been picking up leaves and will be finished Friday. They have also been cleaning up parks and easements, removed hometown banners, installed Christmas banners and snowflake lights, stored summer seasonal equipment and mowers, shutdown water at the parks and winterized the bathrooms at each park, and decorated the Christmas tree and gazebo. Normal maintenance continues with potholes, brush pick up, appliance pickups, installing street signs as per requests by our police department. Senior Center Christmas luncheon is tomorrow at 12 noon. The center will be closed at 11 am on December 19th for the holiday luncheon for Northvale office staff employees. The center will be closed on Christmas Day. Golden Age Club's Christmas party is tonight at Aurora's in Old Tappan. The recreation meeting was held on November 19th. One topic of discussion was the fields at Hogan Park. The committee was curious to know when the dugouts would be installed and they would like to add more clay/dirt onto the infields of the baseball and softball fields. The boys and girls playing baseball or softball this year will now be part of the Little League Charter which will allow our kids to participate in the Little League Williamsport Tournament this summer. The 5/6 grade girls soccer team won the championship and the 7/8 grade boys won their championship. Indoor soccer begins in January. Basketball has 10 recreation teams and 2 travel teams.

Mayor McGuire – thank you to everyone who made our annual tree lighting ceremony at Hogan Park a huge success. Considering the cold and wind, we had an unbelievable turnout. The venue was much better suited to handle all of the children plus two bands, a choir, and a vendor area. Kudos to our DPW for the decorating of the park and Iris Fallon and Kevin Trainor for coordinating the event. The snowflakes look great on the street and more are on their way. Councilwoman McMorrow spoke about the annual Battle of the Bulbs contest. Our Reorganization meeting will take place on Thursday, January 2nd at 6:30 pm, please note this time. It is 6:30 pm and not the usual 7 pm. We also have our annual Sine Die meeting on Monday, December 30th at 7 pm. Just so everyone is clear on the Sine Die, that meeting is meant to finish up any last business for 2024 and there is no public comment at this meeting. Thank you to our local girl scouts. Troop leader Holly Ernst brought the girl scouts to Van Suan Park where they did an excellent job decorating the Northvale tree. Each year every town in Bergen County has a tree designated to them for a decorating contest. While we did not win the contest, the tree looked great and we thank them for representing us so well. Recycling pick up moves to Thursday, December 26th for the Christmas holiday and Thursday, January 2nd for New Years. Kudos to Northvale Police for apprehending two serious criminals caught breaking into the jewelry store in Northvale Square on Tuesday evening. Special thank you to the surrounding communities that helped apprehend the criminals. Great job!

BOROUGH ATTORNEY REPORT

Mr. Ralph had nothing to report at this time.

BOROUGH ENGINEER REPORT

Mr. Loverich – the Senior Center ADA bathroom construction is underway. They should be done by Christmas. Scharer Avenue/Wildwood Road project is complete. There is a catch basin on Andre Avenue that needs repair work done. Will be meeting with the fencing contractor for quotes for the new fencing at Hogan Park.

Mayor McGuire opened the meeting to the public.

Chris Bombino, 123 Rockland Avenue – thanked the Borough for removing the mobile traffic sign. Thank you to Chief Ostrow for putting a patrol car on Chestnut Street which is more effective than the sign. He reported 1 violation to the Police on December 1st. There are a large volume of cars coming down the street and filling up the 17 spots. It is not horrific. Also thank you to our newly tenured Clerk for finding the 5 ordinances that were requested by an OPRA request. Chuck Thomas indicated the maximum capacity is 660. There are 3,600 parishioners.



Just found out the church has private security with Northvale and Norwood Police officers. What is the plan at 119 Rockland Avenue if they are exceeding the occupancy limit on Sundays at 12 noon? Mayor McGuire replied they are working with the Police. The Police are there every Sunday. We will work with Chuck Thomas to confirm the occupancy limit. It could be the 660 is for the worship area not including the classrooms.

Mr. Bombino spoke with the Police, who say it is not their job to keep an eye on the occupancy. Councilman Sokoloski explained the occupancy is up to Fire Prevention and the Building Department. The state sets the limit not Chuck. We will work together to solve this. Mr. Bombino asked if the Mayor will keep him apprised by email about the progress and he will attend Open Mic Nights and meetings. He continued with the variance resolutions say there is no parking. Mayor McGuire informs him that the Planning Board has no authority about parking. Councilman Sokoloski said the Planning Board could have put things in the variance but street parking is not for the Planning Board. Mr. Bombino asked if this would stand up to law. He continued that this ordinance was totally unnecessary. He is disappointed in the total governing body and feels they did not do their homework.

Mayor McGuire asked for a motion and second to adjourn the meeting at 7:49 PM. Motion was moved by Councilman Mattessich, seconded by Council President McMorrow. All were in favor to adjourn.
