## TITLE: RESOLUTION AUTHORIZING EXECUTION OF AGREEMENT BY AND BETWEEN BOROUGH OF NORTHVALE, MASER CONSULTING, P.A. AND NORTHVALE SHOPPING CENTER ASSOCIATES

**WHEREAS,** the Borough is the owner of certain real property commonly known as 254 Livingston Street, Northvale, New Jersey; and

**WHEREAS,** in or about 2013 Northvale Shopping Center Associates ("NSCA") made application to the Northvale Planning Board to develop property identified on Tax Map of the Borough of Northvale and commonly known as Block 303, Lots 5, 6, 8, 13, & 15 and more commonly known as 246-254 Livingston Street, Northvale, New Jersey (the "Property"); and

**WHEREAS,** NSCA obtained approval from the Northvale Planning Board to construct an expanded shopping center by an addition of 15,000 ft 2 to the existing Shop-Rite Supermarket building (the "Building") and a new 24,500 ft 2 retail building on the Property (the "Project"); and

**WHEREAS,** on or about September 11, 2013, NSCA entered into a certain Developer's Agreement with the Borough of Northvale and the Northvale Planning Board setting forth the terms and conditions of NSCA's approval to proceed with the Project(the "Developer's Agreement"); and

**WHEREAS,** pursuant to paragraph 21 of the Developer's Agreement, NSCA agreed to implement certain elements of the Borough's remedial-action obligations for contaminated soil that occurs on the Property; and

**WHEREAS,** the remedial-action obligations stemmed from the Borough's foreclosure of the property (the location of the former Tect, Inc. chemical-specialty-products business), and the Borough's 10+year remedial investigation of the property wherein a variety of volatile organic compounds (VOCs), poly-chlorinated biphenyls (PCBs), and other anthropogenic contaminants were found to have impacted the soil beneath the subject property; and

**WHEREAS,** the Borough retained Maser Consulting, P.A. to serve as the Licensed Site Remediation Professional (LSRP) with the authority to supervise and approve implementation of the soil remedy for the Property, under ultimate authority of the New Jersey Department of Environmental Protection ("NJDEP"); and

**WHEREAS**, the NJDEP's Publicly Funded Site Remediation Element has assumed responsibility for the cleanup of site-related groundwater contaminants; and

WHEREAS, NSCA previously agreed, as set forth in the Developer's Agreement, and continues to agree to be responsible for compensating the Borough's LSRP for the services performed at the Property that ensure program compliance with NJDEP rules and regulations; and

**WHEREAS,** NSCA agreed and continues to agree to compensate the Borough's Engineer for all services provided related to construction oversight, remediation system installation, operation, maintenance, and optimization and other environmental tasks related to the Project as set forth in the Developer's Agreement and as set forth herein; and

**WHEREAS,** it is in the best interest of the Parties to memorialize each parties understanding and responsibilities as to the services provided by the LSRP, the fees to be paid on account of same and the responsible party for the payment of those fees; and

**WHEREAS** the agreement between the Borough of Northvale, Maser Consulting, P.A. and Northvale Shopping Center Associates, annexed hereto as Exhibit A, details the services to be provided by Maser, along with the payment obligations of NSCA (the "Agreement"); and

**WHEREAS**, it is in the best interest of the Borough to execute the Agreement.

**NOW, THEREFORE, BE IT RESOLVED,** that the Governing Body of the Borough of Northvale hereby authorizes the Mayor and Acting Borough Clerk to execute and deliver the Agreement set forth in this resolution.

# TITLE: RESOLUTION AUTHORIZING EXECUTION OF INSTALLATION AND REPAYMENT AGREEMENT BY AND BETWEEN BOROUGH OF NORTHVALE AND PSE&G

**WHEREAS,** PSE&G conducted an energy audit of Borough Hall and the Borough of Northvale Police Department located at 116 Paris Avenue, Northvale, New Jersey 07647; and

WHEREAS, as a result of the audit PSE&G has offered to provide to the Borough participation in its Energy Conservation Program (the "Program") pursuant to the terms and conditions set forth in the proposed Installation and Repayment Agreement (the "Agreement"); and

**WHERERAS**, pursuant to the terms of the Agreement PSE&G shall install all energy conservation measures set forth in the Agreement, said measures to include but not be limited to replacement of the boiler, HVAC and lighting; and

**WHEREAS,** the total project cost is \$107,948.55 with the Borough responsible for the payment of thirty (30%) percent of the total project cost, to be paid in one lump sum payment of \$32,384.56 using bond ordinance funds; and

**WHEREAS,** it is in the best interest of the Borough to enter into the Agreement with PSE&G.

**NOW, THEREFORE, BE IT RESOLVED,** that the Governing Body of the Borough of Northvale, do hereby certify sufficient funds exist for the purpose set forth in this Resolution.

### ON THE QUESTION:

**Resolution** #2020-115 – Ms. Rosendahl explained the agreement and all parties are in agreement. The Borough is not responsible for the LSRP payments, Northvale Shopping Center is. There never was a written agreement.

**Resolution** #2020-116 — Councilman DeLisio asked who recommended purchasing Lenovo laptaps and desktops. Mayor Marana stated that several IT people recommended Lenovo. He specifically asked if Chromebooks would be good enough and the answer was no.

Councilman DeLisio also asked about \$10,000 on the bills list to Chasan Lampanella. The Mayor indicated that these bills were from 2017/2018 for the late Ronnie Magnani two family house litigation.

**Resolution** #2020-117 – Mayor Marana explains the PSE&G energy audit that was done of the Borough Hall and Police Department. The agreement is to replace the A/C unit, 2 boilers, and replacing fixtures and bulbs with LED lighting. He said the energy bills will be reduced by an estimated \$600. The estimate for the project is \$107,948.55. PSE&G will pick up \$75,563.99 of that amount. The Borough can make a lump sum payment of \$32,400 using bond funds. Councilman Devlin setup a meeting with the sales rep for Tuesday, September 15<sup>th</sup>. Councilman McGuire stated the proposal is a better deal for efficiency. Mayor Marana agreed this is a great deal.

**Edward Durfee, 215 Livingston Street** – asked if the Council is going to get 3 quotes for the boiler. Mayor Marana answered that we have quotes in place. Mr. Durfee asked if the vote for Resolution #2020-117 is to get 3 quotes. Mayor Marana said they are voting to approve the agreement because we want to lock in the pricing.

### **ORDINANCE #1024-2020**

### ORDINANCE AMENDING AND MODIFYING SECTION CHAPTER 200, ARTICLE 15 OF THE BOROUGH CODE

**Section 1. Purpose & Authority.** The purpose of this ordinance is to modify and amend Chapter 200-15, Fences and Walls, fee pursuant to <u>N.J.S.A.</u> 40:48-1, and 40:49-2.

**Section 2. Amendments.** (amendments are highlighted, deletions strikethrough).

### 200-15 Fences and fence walls.

A. Residential zones.

- (1) No fence or fence wall in a required yard shall exceed six feet in height, measured from the highest point of ground at its base, except where required by this chapter to screen parking areas. No fence or fence wall in any required front yard shall exceed three feet in height.
- (2) No fence, shrubs or other obstruction to visibility, exclusive of trim trees or existing buildings, shall be built, planted or maintained upon a corner lot within 25 feet of any street intersection. Any existing obstruction of this character which within the foregoing limits curtails the view of drivers of vehicles approaching the intersection shall be removed

by and at the expense of the owner of such corner lots within six months of the date of the passage of this chapter.

- (3) No fence or fence wall (except a retaining wall) over six feet in height shall hereafter be erected within 10 feet of a property line. Any fence or fence wall erected pursuant to this chapter in a residential zone shall be placed such that its good side faces outwards from the property on which it is so erected
- (4) No fence wall and/or retaining wall shall be constructed within five feet of any fence.
- **Section 3. Repealer.** All prior ordinances that are inconsistent with this ordinance are repealed. All ordinances are hereby amended to be consistent with this ordinance and all ordinances, including this one, shall be construed consistent with the express purpose of this ordinance.
- **Section 4. Savings and Construction.** This ordinance shall be construed consistent with the purpose stated in Section 1 hereof. Any ambiguities in this ordinance shall be construed in accordance with the purpose of this ordinance. If any part of this ordinance is invalidated by a court of competent jurisdiction, the remainder of this ordinance shall be saved to the full extent possible. This ordinance repeals provisions of the Northvale Code only where stated herein; otherwise this ordinance is amendatory and supplementary to existing provision of the Northvale Code.
- **Section 5.** Codification. This ordinance shall be codified as amendments to the chapters set forth herein.
- **Section 6. Effective Date.** This ordinance shall take effect immediately upon approval and publication of notice of adoption as provided by law.

### **MAYOR & COUNCIL REPORTS**

**Councilman Sotiropoulos** – reported on the Police Department activity for the month. There has been one new COVID case on September 8<sup>th</sup>. The DPW has been catching up after the storm. They have been working with the Police to install solar powered speed signs and

crosswalk signs. He also reported on all the various work they have been doing in town. Ambulance Corps is hurting for members. There will be a meeting next Tuesday.

**Councilman McGuire** – reported that school started last week. There are 38% of families that have kept their children at home to be completely online. There is outdoor space available for classes. The High School started with a complex schedule. Fall sports at the high school have a limited schedule, practices begin on the 14<sup>th</sup>.

**Councilman Argiro** – reported the Library is operating with limited hours. They offer virtual programs and have good attendance. They are waiving any late fees. The DPW did a great job with maintaining the fields. The playgrounds are open. Adult softball is winding down. Soccer is underway at both parks. Amy Ibrahimaj is stepping down as Recreation Director. She has done a fantastic job and handled the job gracefully and with class. Best of luck to Amy.

**Councilman DeLisio** – reported on Northern Valley Greenway progress. They are pursuing receiving funding.

**Councilman Devlin** – reported that the Senior Center and Golden Age are closed. The Planning Board meeting scheduled for September 16<sup>th</sup> will be 411 Clinton application. The Fire Association President and Vice President met with the Mayor to discuss combining Town Day and the 125th Anniversary on a Saturday in June next year with fireworks at night.

Mayor Marana – reported that the county will be paving Livingston Street from Norwood to Paris Avenue. They will restripe everything to the New York state border. There are 20 outstanding tax appeals in progress. The delinquent notices seem to have had an effect since the August 1 tax collection delinquencies have gone down, Aug 11 - \$617,000; Aug 18 -\$448,000; Aug 28 - \$321,000, and Sept 8 - \$227,000. Borough Hall was reopened to the public on September 1. Hand sanitizers have been installed at the building entrance, at each window and at the entrance to the council chambers. Distancing decals have been affixed to the floor. We already had plexiglass barriers. Additional signage has been put up. Everyone from the public must wear a face mask in the building. Playgrounds reopened on August 26 after a three week delay due to storm clean-up efforts. Building Department revenue is tracking under budget. Rio Vista received DEP approvals and will be coming in with engineering documents. This project will be moving along. Appropriations are running flat vs. budget. VFW property has been approved for the sub division by the Planning Board. The new map has been sent to the County Clerk's office to be filed. The attorney can now start working on an ordinance that is required to pass to sell the property. A second preconstruction meeting was held at the Clinton Avenue crossing on September 3<sup>rd</sup>. We received a revised traffic notice from DOT stating the crossing will be closed September 19th at 7:00 AM until September 25th at 7:00 AM. This is still subject to change. It also says the existing Railroad Crossing will be removed and a new concrete Railroad Crossing will be installed with new asphalt approaches. We have been lobbying for the concrete. The DOT will be picking up the responsibility and cost for all of the jobs that were supposed to be the Borough's responsibility.

### **BOROUGH ENGINEER REPORT**

**Ms. Raffay** – reported on the various projects. They are working on the applications and licensing agreement for CSX. They are coordinating repairs for Union Street. They are closing out the old DOT grants.

### **BOROUGH ATTORNEY REPORT**

**Ms. Rosendahl** – had nothing to report. She had some issues to discuss in closed session.

### **OPEN MEETING TO THE PUBLIC**

**Andrew Durfee, 174 Walnut Street** – asked how they could get one of the new speed signs on Walnut Street. Mayor Marana advised that he would speak with the Chief and said maybe the portable sign could be put on Walnut Street. Mr. Durfee reiterated how dangerous Walnut Street is. Mr. Durfee also complimented the butterfly gardens.
