RECOMMENDATIONS

1. Bank reconciliations should be prepared on a monthly basis to ensure all transactions have been accounted for and recorded in the Borough's accounting system.
2. A detailed analysis of the compensated absence liability as of year-end should be prepared and available for audit.
3. The Borough should establish and maintain a fixed asset accounting system that complies with N.J.A.C. 5:30-5.6, including procedures to record all additions, deletions, and other changes in municipal property on an annual basis.
4. Old and outstanding grant contributions/receivables should be investigated and cancelled if deemed uncollectible.
5. That more care be taken to ensure expenditures are not made in excess of appropriations.
6. All purchase orders should include approval of purchase order and appropriate authorization signatures.
7. The awarding resolutions for professional service contracts should contain all necessary language as required by N.J.S.A. 5:30-5.4(a)(2).
8. That all stale dated outstanding checks be reviewed and voided as appropriate.
9. All interest earnings should be remitted to the Borough in a timely manner.
10. That tickets assigned but not issued over 180 days be recalled or reissued.
11. That departmental receipt subledgers be totaled monthly and agreed to the general ledger.

A Corrective Action Plan outlining actions to be taken by the Borough of Northvale to correct the above findings will be prepared in accordance with federal and state guidelines. A copy of the plan will be on file and available for public inspection with the Municipal Clerk in the Borough of Northvale no later than 45 days from when the audit was received in compliance with directives from the Division of Local Government Services.
