- Section 3. The Local Finance Board is hereby respectfully requested to consider such application and to record its findings, recommendations and/or approvals as provided by the applicable New Jersey Statute and to cause its consent to be endorsed upon the Bond Ordinance.

WHEREAS, Frances Weston has served as the Deputy Municipal Clerk for the Borough of Northvale; and

WHEREAS, the personnel committee of the Borough has met and conferred and identified Frances Weston, who it believes possesses the experience necessary and appropriate to perform the function of the Acting Municipal Clerk in the highest professional manner; and

WHEREAS, it is in the best interests of the Borough of Northvale to appoint Frances Weston as Acting Municipal Clerk for the Borough of Northvale for a term not to exceed one (1) year.

NOW, THEREFORE, BE IT RESOLVED, that the Governing Body of the Borough of Northvale hereby appoints Frances Weston as Acting Municipal Clerk commencing on March 11, 2020 for a term not to exceed one (1) year and at an annual salary of Fifty Six Thousand Five Hundred (\$56,500.00) Dollars.

ORDINANCE #1018-2020

REFUNDING BOND ORDINANCE PROVIDING FOR THE FUNDING OF A \$313,625 EMERGENCY TEMPORARY APPROPRIATION FOR TAX APPEALS IN, BY AND FOR THE BOROUGH OF NORTHVALE, IN THE COUNTY OF BERGEN, NEW JERSEY, AND AUTHORIZING THE ISSUANCE OF \$350,000 OF BONDS OR NOTES TO FINANCE SUCH EMERGENCY TEMPORARY APPROPRIATION.

WHEREAS, the Borough Council of the Borough of Northvale, in the County of Bergen, New Jersey, pursuant to a resolution adopted on March 11, 2020 in accordance with N.J.S. 40A:4-20, made an emergency temporary appropriation in the amount of \$313,625 to pay tax refunds resulting from property tax appeals; and

WHEREAS, the Borough Council of said Borough has determined that it is in the best interest of the Borough to fund the \$313,625 emergency temporary appropriation, pursuant to the provisions of N.J.S. 40A:2-51, by the adoption of a refunding bond ordinance providing for payment thereof, including expenses, and authorizing the issuance of \$350,000 of bonds or notes of said Borough to finance the funding of said emergency temporary appropriation; NOW, THEREFORE,

BE IT ORDAINED by the Borough Council of the Borough of Northvale, in the County of Bergen, New Jersey, as follows:

- **Section 1**. The Borough of Northvale, in the County of Bergen, New Jersey (the "Borough") is hereby authorized to fund the \$313,625 emergency temporary appropriation for tax appeals previously made pursuant to a resolution adopted by the Borough Council of the Borough on March 11, 2020.
- **Section 2.** The Borough Council of the Borough hereby determines that the Borough is authorized by Section 51(a) of the Local Bond Law (Chapter 2 of Title 40A of the New Jersey Statutes Annotated, as amended; the "Local Bond Law") to issue its refunding bonds or notes as hereinafter provided to pay or fund the \$313,625 emergency temporary appropriation set forth in Section 1 hereof.
- **Section 3.** The sum of \$36,375 is hereby appro¬priated to pay the cost of the issuance of refunding bonds or notes and expenses in connection with the tax appeals, including printing, advertising, accounting and financial and legal expenses therefor permitted by Section 51(b) of the Local Bond Law.
- To finance the funding of the \$313,625 emergency temporary Section 4. appropriation and the \$36,375 appropriation for costs in connection therewith (collectively, hereinafter referred to as purpose), bonds of said Borough of an aggregate principal amount not exceeding \$350,000 are hereby authorized to be issued pursuant to the Local Bond Law (the "Refunding Bonds"). The Refunding Bonds shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law. The Refunding Bonds shall be direct and general obligations of said Borough and said Borough shall be obligated to levy ad valorem taxes upon all the taxable real property within said Borough for the payment of the principal of the Refunding Bonds and the interest thereon without limitation as to rate or amount. The full faith and credit of said Borough shall be and are hereby pledged for the punctual payment of the principal of and interest on the Refunding Bonds. Each Refunding Bond issued pursuant to this ordinance shall recite that it is issued pursuant to the Local Bond Law and shall also recite that all conditions, acts and things required by the Constitution or statutes of the State of New Jersey to exist, to have happened and to have been performed precedent to and in the issuance of said bond exist, have happened and have been performed, and that said bond, together with all other indebtedness of said Borough, is within every debt and other limit prescribed by the Constitution or statutes of said State. All matters with respect to said bonds not determined by this ordinance shall be determined by resolutions to be hereafter adopted, except that the Refunding Bonds shall mature at such time or times, not exceeding 40 years from their date, as may be approved by the Local Finance Board.
- **Section 5.** To finance said purpose, bond anticipation notes of said Borough of an aggregate principal amount not exceeding \$350,000 are hereby authorized to be issued pursuant to the Local Bond Law in anticipation of the issuance of said bonds. In the event that bonds are issued pursuant to this ordinance, the aggregate amount of notes hereby authorized to be issued shall be reduced by an amount equal to the principal amount of the bonds so issued. If the aggregate amount of outstanding bonds and notes issued pursuant to this ordinance shall at any time exceed the sum first mentioned in this section, the moneys raised by the issuance of said bonds shall, to not less than the amount of such excess, be applied to the payment of such notes then outstanding.
- Section 6. Each bond anticipation note issued pursuant to this ordinance shall be dated on or about the date of its issuance and shall be payable not more than on year from its date, shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law and may be renewed from time to time pursuant to and within limitations prescribed by the Local Bond Law and the Local Finance Board. Each of said notes shall be signed by the Mayor and by a financial officer and shall be under the seal of said Borough and attested by the Borough Clerk or Deputy Borough Clerk. Said officers are hereby authorized to execute said notes and to issue said notes in such form as they may adopt in conformity with law. The power to determine any matters with respect to said notes not determined by this ordinance and also the power to sell said notes, is hereby delegated to the Chief Financial Officer who is

hereby authorized to sell said notes either at one time or from time to time in the manner provided by law.

Section 7. It is hereby determined and stated that the Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the office of the Borough Clerk of said Borough, and that such statement so filed shows that the gross debt of said Borough, as defined in Section 43 of the Local Bond Law, is increased by this ordinance by \$350,000, but said \$350,000 shall be deducted from gross debt pursuant to Section 52 of the Local Bond Law, and that the issuance of the bonds and notes authorized by this ordinance will be within all debt limitations prescribed by said Local Bond Law.

Section 8. It is hereby determined and stated that (A) a certified copy of this refunding bond ordinance as passed on first reading shall be filed with the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey prior to the final adoption thereof, together with a complete statement in the form prescribed by said Director and signed by the chief financial officer of the Borough as to the outstanding tax refund amount to be financed by the issuance of the Refunding Bonds or the notes and (B) no sum need be appropriated hereby as a down payment.

Section 9. This ordinance shall take effect twenty days after the first publication thereof after final passage, provided that the consent of the Local Finance Board has been endorsed upon a certified copy of this ordinance as finally adopted.

BE IT ORDAINED, by the Mayor and Council of the Borough of Northvale, County of Bergen, State of New Jersey, as follows:

Section 1. Purpose & Authority. The purpose of this ordinance is to modify and amend Chapter 74, Background Checks, Article 1, Borough Employees and Volunteers Working with Minors, pursuant to N.J.S.A. 40:48-1, and 40:49-2.

Section 2. Amendments. (amendments are highlighted, deletions strikethrough).

74-3 (C) The determination of whether the information contained in the criminal history record is sufficient to disqualify an employee or volunteer shall be made by the state police. A challenge to the accuracy of the report shall be filed with the Municipal Chief of Police, who shall coordinate the challenge with the appropriate agency.

Section 3. Repealer. All prior ordinances that are inconsistent with this ordinance are repealed. All ordinances are hereby amended to be consistent with this ordinance and all ordinances, including this one, shall be construed consistent with the express purpose of this ordinance.

Section 4. Savings and Construction. This ordinance shall be construed consistent with the purpose stated in Section 1 hereof. Any ambiguities in this ordinance shall be construed

in accordance with the purpose of this ordinance. If any part of this ordinance is invalidated by a court of competent jurisdiction, the remainder of this ordinance shall be saved to the full extent possible. This ordinance repeals provisions of the Northvale Code only where stated herein; otherwise this ordinance is amendatory and supplementary to existing provision of the Northvale Code.

Section 5. Codification. This ordinance shall be codified as amendments to the chapters set forth herein.

Section 6. Effective Date. This ordinance shall take effect immediately upon approval and publication of notice of adoption as provided by law.

There was a gas leak at the Borough Hall. The DPW contacted Nick Varni who came and did the repairs. Lights were installed on the flagpoles at the Borough Hall and Hogan Park. Briant's wife's company is moving and had a lot of metal to get rid of. The DPW dropped off a container and disposed of the scrap metal and the Borough received several thousand dollars.

Councilman Argiro – reported that Recreation had their monthly meeting. Rich Fleury spoke on the coronavirus affecting sports. Basketball regular season is running down. Brandon did a phenomenal job. Indoor soccer playoffs are on Sunday. Opening Day is April 25th. Applebee's fundraiser date has not been determined as yet. Dick's in Paramus gave Recreation 20% coupons. The Library will be having an interior renovation.

Councilman McGuire – reported that the Spring Luncheon at the Senior Center will be held on April 4th. Cho Dae Golf Outing is May 11th. Town Day is September 12th. The Fire Department has started preparations for their 125th anniversary in 2021. Camp Northvale registration is April 16th. NVOT Junior Prom is March 12th and the Senior Prom is June 5th. All schools are preparing for closings due to the coronavirus.

Councilman DeLisio – reported he had a conference call with the Department of Education in reference to potential school closings. The Commissioner is willing to waive the 180 day mandate as long as there is adequate instruction for the students. Plans are being submitted to Mr. DeLisio for review. The Bergen County Technical School is closed.

Councilman Shepard – reported that Rich Scaglione and Leigh Meola are working on the butterfly garden at Veterans Park. The Fire Department has their 125th anniversary in 2021. Fire Prevention had 53 inspections.

Councilman Devlin – reported that the duct work cleaning at the Senior Center is completed. The DPW changed the dirty ceiling tiles. Senior Center's St. Patrick's Day Party is March 12th. Planning Board had 2 short meetings. The Board of Health meeting will be March 19th.

Mayor Marana – stated that the Master Plan Reexamination is done every 10 years. He thanked Bill Sillery and Ed Giannotti for doing the bulk of the work with Darlene Green, the Borough Planner. The Open Space Grant is due April 30th. The CSX preconstruction meeting was held on March 3rd. There will be 3 phases. Phase 1 and 2 will be the roadwork and drainage. The original estimate is to have the crossing closed for 5 days. They will start after school closes. Phase 3 will be installing the safety equipment. They will work on the weekends if necessary when the crossing is closed. Maser has developed the subdivision for the VFW building. Mayor Marana will show the Planning Board at the next meeting. Mayor Marana contacted Linda from L Ross Cleaning for a quote to deep clean the Borough Hall. The quote was \$2300. There will be a meeting on March 18th to discuss postponing the Cho Dae Golf outing. The County has shut down all County run Senior Centers. The Mayor says the borough should follow the county plan.

Ms. Raffay reported on the various projects Maser Consulting has been working on. Riverside Coop will go out to bid on Monday. They have been working with Millenium Strategies for grants.
