Ms. Caperini informed the members that all inspections have been done. There is a new truck coming to town called Scream truck. It is like door dash and wonder truck combined. You would order on an ap and the truck comes to your house and makes the food in front of your house. Ms. Caperini also stated that the Scream truck would have to get a food license from the town. She had spoken to them but they have not yet contacted the town.
