RESOLUTION #2023-188

TITLE: RESOLUTION AUTHORIZING EXECUTION OF SHARED SERVICES AGREEMENT WITH THE BOROUGH OF OLD TAPPAN

WHEREAS, the Uniformed Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq., allows any municipality to enter into a contract with any other municipality or local unit for the joint provision of any services within their joint jurisdiction; and

WHEREAS, the need exists in the Borough of Northvale to enter into a Shared Services Agreement with the Borough of Old Tappan whereby the Borough of Old Tappan will provide to Northvale, at Northvale's request, services and goods for motor vehicle and other mechanical maintenance and repairs ("the Services"); and

WHEREAS, the Borough of Northvale and the Borough of Old Tappan have negotiated a shared services agreement setting forth the terms and conditions of the services to be provided by Old Tappan and all payment rates; and

WHEREAS, it is in the best interest of the Borough of Northvale to execute the Shared Services Agreement with the Borough of Old Tappan.

NOW, THEREFORE BE IT RESOLVED, by the Governing Body of the Borough of Northvale, that the Mayor is hereby authorized to execute the Shared Services Agreement between the Borough of Northvale and the Borough of Old Tappan.

RESOLUTION #2023-189

TITLE: RESOLUTION AUTHORIZING A CONTRACT WITH ARCARI + IOVINO FOR ARCHITECTURAL SERVICES FOR A CDBG FUNDED GRANT – JAMES F. MCGUIRE SENIOR CENTER ADA RESTROOMS

WHEREAS, the Borough is in need of an ADA restrooms for the James F. McGuire Senior Center; and

WHEREAS, there is funding for this project through a Community Development Block Grant; and

WHEREAS, the firm of Arcari +Iovino is familiar with the administration process for this grant and can provide the necessary architectural services; and



WHEREAS, Arcari + Iovino has submitted a proposal dated December 15, 2023 for their services for this project in the sum of \$14,000, which service and amount does not require competitive bidding; and

WHEREAS, the Borough finds the proposal to be reasonable and suited for the project.

NOW, THEREFORE BE IT RESOLVED, by the Governing Body of the Borough of Northvale that the Governing Body does accept the proposal by Arcari + Iovino and does hereby authorize the execution of an agreement by the Mayor and Municipal Clerk with Arcari + Iovino for the services set forth herein.

RESOLUTION #2023-191

TITLE: RESOLUTION AUTHORIZING AMENDING THE EMPLOYEE HANDBOOK

WHEREAS, the Borough of Northvale has reviewed its employee handbook and wishes to revise the provisions regarding Vacation Leave in order to remove any ambiguity so that the handbook complies with State Law.

NOW, THEREFORE BE IT RESOLVED, by the Governing Body of the Borough of Northvale hereby amends the Employee Handbook Section VII Paid and Unpaid Leave and in particular Section VII C. Vacation Leave to read as follows:

C. Vacation Leave



Paid Vacation is granted in full day increments to full-time employees and shall accrue based on years of service as follows:

- Ten days after (1) year of service
- Twelve days after (5) years of service
- Fifteen days after (10 years of service
- Twenty days after (15) years of service.

Employees who are covered by a collective negotiations agreement shall abide by the vacation schedule set forth within the applicable agreement. All vacations must be approved by the employee's supervisor in accordance with established Employer guidelines. We do not provide vacation to part-time employees.

Vacation days may not be accumulated for more than $\frac{1}{1000}$ one (1) prior calendar year. Any unused vacation days carried forward from one calendar year into the next must be used during the second year or shall be forfeited. Employees will be paid for any accrued but unused vacation upon separation of employment. in such amounts as may be permitted by state law.

RESOLUTION #2023-192

TITLE:RESOLUTION AUTHORIZING THE HIRING OF THREE NEW POLICEOFFICERS

WHEREAS, the Borough of Northvale believes it is in the best interest of the Borough to hire three (3) new police officers; and

WHEREAS, the Borough's Police Chief has recommended this hiring as being in the best interest of the Borough of Northvale Police Department; and

NOW, THEREFORE BE IT RESOLVED, by the Governing Body of the Borough of Northvale that the Governing Body hereby authorizes the hiring of three (3) new police officers; and

BE IT FURTHER RESOLVED, that the swearing in of the new officers shall be determined upon the start date of the next Basic Police Officers Class held by the Bergen County Police Academy.
