ON THE QUESTION – Councilman Hogan mentioned that Resolution #2023-151 shows we are authorizing Mayor Patrick J. Marana to execute that grass agreement and should be corrected. He also asked if the type of vehicle was purposedly left off of Resolution #2023-158. Mayor McGuire replied yes it was. Chief Ostrow explained that there were 3 quotes submitted to our Qualified Purchasing Agent since this was not through state contract.

OPEN MEETING TO THE PUBLIC

Ken Cho, 423 Wildwood Road – asked if the vehicles being purchased through Resolutions 2023-157 and 158 will have additional expenditures to retrofit them for communications and if so, is that budgeted. Chief Ostrow answered yes these vehicles are being paid out of forfeiture funds.

MAYOR & COUNCIL REPORTS

Council President McMorrow – the Police Department for the month of September had 83 motor vehicle stops, 57 selective traffic enforcement details, 47 medical calls, 32 burglar alarms, 26 suspicious incident calls, 25 civilian assists, 23 motor vehicle crashes, 13 verbal disputes, and 2 residential burglaries. There were a few arrests made. A 57 year old male for credit card theft, 41 year old male for terroristic threats, 21 year old male for eluding a law enforcement officer, and a 62 year old male for theft by unlawful taking. September 13th and 14th motor officers attended yearly 2 day recertification course. On September 18th, the department conducted mandated active shooter training using Borough Hall. September 19th, officers participated in the Shop Rite Drive for Hunger event and on September 22nd, officers attended mandated yearly domestic violence update training. The Preschool Carousel Cake fundraiser is underway. There is still availability in the Pre-K 3 year old class. The Fire Department will be visiting the Preschool on October 20th. The children will be going trick or treating at the Borough Hall and Senior Center. Their first field trip is this Friday to the pumpkin patch at Demarest Farms. The children will also take part in the Tree Lighting on December 1st. The Ambulance Corps had 25 calls for the month of September. Ambulance Corps. is in desperate need of volunteers.

Councilman Argiro – check out the Library's website and calendar for all activities for adults and children. Soccer is winding down. Thank you to the coaches and parents who made it another great successful season. Registration is open for winter soccer and basketball. Joel Negron is the new Basketball Commissioner. Brandon will assist for one year. Cho Dae is allowing recreation to use their facilities for basketball practices on Tuesdays and Thursdays 4:00-7:30 pm.



Councilman Menafra – the Fire Department website is now live. The cost to run and maintain the website is covered by the grant so there is no cost to the taxpayers. Lt. Witkowski is working with Mr. Pinajian and Ms. McGrath to schedule fire awareness and safety information sessions with the students. Fire Department had 36 calls for the month of September. Fire Prevention did 21 inspections and 10 reinspections for the month of September. Municipal Alliance is working with the school and Senior Center to select programs and dates. Northvale Board of Education's last meeting was September 21st. Back to school night went very well. Boys and girls volleyball teams and soccer team won their opening season games. Mr. Pinajian attended a replacement of the lighting detection meeting. The cost of replacement will be \$25,000 which will be split between the school and Borough. Some of the other towns in Bergen County have online access to lightning detector by going to their borough website to see when the last strike was and when the field will be cleared for use. Paving, concrete, and seeding around the annex building has taken place. The roofing is nearly completed. Konan Ice fundraiser will be held on October 12th. PTO Halloween party is scheduled for October 27th. Korean families are organizing another international night. The date has not yet been determined. Northern Valley Board of Education had a meeting on September 11th. Principals of each campus made a mandatory presentation on violence and vandalism for the reporting period of January through June 2023. There were 9 confirmed hib cases at Old Tappan campus and 6 confirmed hib cases at Demarest. There was parent feedback on the rear gate which continues to be open before school and after. There was a roof leak at Old Tappan which caused some volleyball games to be rescheduled. The Business Administrator mentioned roofing is included in their yearly budget and they replace it based on service life of the roof. The next meeting is October 16th at 7:00 PM.

Councilman Mattessich – DPW has been working on various jobs such as installing the nets on the goal posts, painting soccer fields, repaired the handicap button at the Library, brush pick up in Rockleigh, installed shelf in Preschool, painted and put in a new floor in Borough Hall bathroom, installed street signs and many other jobs. Met with Michelle at the Senior Center. Seniors continue normal activities such as strength in training, crochet, line dancing, and bingo continues. Jewish Home did a presentation today on rehabilitation and home safety. Michelle appreciated the painting of the walls and the new Northvale seal at the Center. There is a pottery class on October 25th. Also met with Augie from the Golden Age Club. Their next trip is next month to a comedy show at the Brownstone in Paterson.

Councilman Hogan – asked why the Personnel Committee didn't let the Council know we were hiring a new Police Officer. He had to see it on the sign in front of the Borough Hall. Chief Ostrow explained that he sat with the Mayor and CFO. The CFO budgeted for the hiring of an officer this year. Once the application closes, he will come to the Mayor and Council with the complete report as to how many applicants were received. The Building Department issued 22 permits for the month of September and collected \$21,622 in fees. The year to date is \$118,893 which is still very behind from the budgeted amount. Planning/Zoning Board meetings scheduled for September 20th and October 4th were all cancelled due to lack of applications ready to be heard. Next meeting is scheduled for October 18th. The BCUA held the shredding event on September 30th in the Borough Hall parking lot. The Women's Club will be having a beefsteak on October 20th at the Legion at 6:30 PM. Tickets for adults are \$55, children under 10 are \$30. There will be a 50/50, door prizes, and a tricky tray. For tickets contact Mary Capellini at 201-988-5351 or Sandy Grassi at 201-768-7321. This is for a good cause to benefit local families in crisis.

Councilman Sokoloski – the Board of Health meeting is scheduled for October 19th. Northern Valley Greenway met last week and he was unable to attend. The Bergen County Community Development Grant is due in December. He spoke with the Grantswriter about the Senior Center. Prior to 2016, Northvale received the greatest amount from those grants to subsidize the operation of the Senior Center. Now, Northvale is picking up the cost to run the Senior Center. The Grantswriter will look into, but not very confident, to subsidize the operation.

Mayor McGuire – happy to report that taxes are now online. If you go to our website, click on tax information and taxes can be paid electronically. This will cut down on calls asking what is owed, checks lost in the mail, and deposits to the bank. Our annual Veterans Day ceremony will take place on November 11th at 11:00 am in front of the Borough Hall. Refreshments will be served in the Senior Center. The tree lighting will be held on December 1st at 6:30 pm. Paris



Avenue in front of the Borough Hall will be closed off again as we did last year. The security cameras project for Hogan Park has been delayed a little. Installation should begin the first part of December. The company doing the installation has had delays getting the equipment. We did an analysis of the amount of money we spent paying our Professionals through September of this year. We have spent approximately \$250,000 less than in 2022. Hope this will continue through the end of the year and help us to plan better for the 2024 budget. We are trying to cut costs as much as we can. He is working with the Risk Manager to help us defer health insurance cost for 2024.

BOROUGH ATTORNEY REPORT

Mr. Ferraro – received OPRA requests from the Police and the Clerk. Would like to compliment the Police Department and Ms. Weston on responding to the requests in a timely manner.

BOROUGH ENGINEER REPORT

Mr. Loverich – Westcott Street milling will be done tomorrow afternoon with paving on Friday. Once this is done, that will complete the Riverside Coop Paving Program for 2023. Bid opening for Veterans Drive Phase II will be held on October 25th. The plans have been sent to the County and DOT for review for Livingston Street Streetscape. Once we receive approval, we can go out to bid. He will work on the contracts tomorrow for the Senior Center ADA doors. Precon meeting will be scheduled and the project should be done early December. We will begin design work for the Senior Center ADA bathroom project which is for 2024. For Veterans Drive Phase II, we are coordinating with Orange and Rockland who will be doing improvements in this area. Paving should be in the summer of 2024.

OPEN MEETING TO THE PUBLIC

Chief Howard Ostrow – there was an event that occurred today. At 9:45 am, Mayor McGuire contacted him about a social media post which stated a question, has anyone heard shots or an explosion on Paris Avenue. This post started a waterfall of phone calls. Within 5 minutes, he received 8-10 notifications on his phone. After investigating, there was a local Police Department using Closter firearms training facility that was the cause. There was also construction in Rockleigh at the old Bergen County Nursing Home where walls were being taken down that may have been heard as an explosion. The Police posted on social media sites explaining what it was. Social media posts continued and made itself to the Preschool. In situations like this social media has its disadvantages. Please call 911 or the local Police Department instead of putting it on all of social media. There was no danger to anyone in the community.

ADJOURNMENT

Mayor McGuire asked for a motion and second to adjourn the meeting at 7:40 PM. Motion made by Councilman Menafra, seconded by Councilman Mattessich. All were in favor to adjourn.
