#### AN ORDINANCE TO FIX THE SALARIES, WAGES AND COMPENSATION OF POLICE EMPLOYEES OF THE BOROUGH OF NORTHVALE, COUNTY OF BERGEN AND STATE OF NEW JERSEY. (Year 1 of 5 Year Contract- 2.50%

**BE IT ORDAINED,** by the Mayor and Council of the Borough of Northvale, County of Bergen, State of New Jersey, as follows:

**Section 1.** That the following annual salaries, wages, and compensation shall be paid to Police Employees of the Borough of Northvale in the amounts set forth opposite their respective title and commencing on January 1, 2023, through December 31, 2023:

**Section 2.** In addition to the compensation set forth in Section 1, each full time member of the Police Department hired before January 1, 2012, shall receive longevity pay as follows:

2% of annual base pay after 7 years of service 4% of annual base pay after 10 years of service 6% of annual base pay after 13 years of service 8% of annual base pay after 17 years of service 10% of annual base pay after 21 years of service

The following longevity schedule will take effect for all employees hired after January 1, 2012:

1.5% of annual base pay after 8 years of service3% of annual base pay after 10 years of service5% of annual base pay after 13 years of service8% of annual base pay after 17 years of service10% of annual base pay after 21 years of service

If an employee reaches a higher plateau of longevity entitlement at any time during the calendar year, then said employee shall be entitled to receive the full value of the higher plateau.

**Section 3.** Time in excess of the basic work week or tour for a day performed by a Lieutenant, Sergeant or Patrolman shall be compensated for at the rate of time and one-half.

**Section 4.** Each full-time member of the Police Department under Contract shall receive a lump sum compensation for thirteen (13) holidays, payable between December 1 and 5, 2023.

**Section 5.** There shall be paid to each full-time member of the Police Department during the year of attainment of college credits towards a Police Science Degree and in each year of service thereafter the sum of:

- \$ 300.00 upon completion of 25 credits
- \$ 600.00 upon completion of 45 credits
- \$1,000.00 upon completion of an Associate's Degree
- \$1,500.00 upon completion of a Bachelor's Degree

Where an employee qualifies for a higher plateau of credits during the first half of a calendar year (January 1 through June 30), then said employee shall be entitled to higher educational incentive payments starting the first day of July 1 of that same year and in each year of service thereafter. In the event that an Employee qualifies for a higher plateau of credits during the last half of the calendar year (July 1 through December 31), then the entitlement to higher educational compensation shall commence with the following January 1 and in each year of service thereafter.

Section 6. All full time employees of the Police Department shall be paid bi-weekly.

Section 7. All ordinances or parts of ordinances inconsistent herewith are repealed.

**Section 8.** This ordinance shall take effect immediately after passage and publication according to law.

# **ORDINANCE** #1073-2023

# AN ORDINANCE TO AMEND AND REVISE CHAPTER 186 "VEHICLES AND TRAFFIC" OF THE BOROUGH CODE OF THE BOROUGH OF NORTHVALE AND IN PARTICULAR SECTION §186-19 TO PROHIBIT PARKING AT CERTAIN TIMES ON CERTAIN STREETS

WHEREAS, the Governing Body of the Borough of Northvale believes it is in the best interest of the Borough to amend and revise §186 entitled "VEHICLES AND TRAFFIC" of the Borough Code to as set forth herein.

**BE IT ORDAINED,** by the Mayor and Council of Northvale, County of Bergen, State of New Jersey, as follows:

**SECTION 1.** §186-19 of the Borough Code of the Borough of Northvale, entitled "Parking during certain hours on certain streets" is hereby amended and revised to add the following:

#### § 186-19 Parking prohibited during certain hours on certain streets.

No person shall park a vehicle between the hours specified of any day upon any of the streets or parts of streets described:

Walnut Street	West	Prohibited Sundays and Holidays 8:00 a.m. to 1:00 p.m.	From Rockland Avenue to Legrand Avenue

**SECTION 2.** All ordinances of the Borough of Northvale, which are inconsistent with the provisions of this ordinance, are hereby repealed to the extent of such inconsistency.

**SECTION 3**. If any section, subsection, clause or phrase of this ordinance is for any reason held to be unconstitutional or invalid by any court or competent jurisdiction, such decision shall not affect the remaining portion of this ordinance.

**SECTION 4**. All other provisions of §186 of the Code of the Borough of Northvale are not further amended and remain in full force and effect.

The ordinance shall take effect immediately upon final passage.

#### **ORDINANCE #1074-2023**

BOND ORDINANCE TO AUTHORIZE THE ACQUISITION OF NEW ADDITIONAL OR REPLACEMENT EQUIPMENT AND MACHINERY AND NEW INFORMATION TECHNOLOGY AND TELECOMMUNICATIONS EQUIPMENT IN, BY AND FOR THE BOROUGH OF NORTHVALE, IN TH ECOUNTY OF BERGEN, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$105,000 TO PAY THE COST THEREOF, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS

**BE IT ORDAINED,** by the Borough Council of the Borough of Northvale, in the County of Bergen, State of New Jersey, as follows:

Section 1. The Borough of Northvale, in the County of Bergen, State of New Jersey (the "Borough") is hereby authorized to acquire new additional or replacement equipment and machinery and new information technology and telecommunications equipment in, by and for the Borough consisting of: (A) <u>Fire Department</u> – ventilation fans, fire hose, protective equipment, swift water rescue equipment, thermal imaging cameras and other equipment; (B) <u>Building Department</u> - office equipment; and (C) <u>Various Borough Departments</u>, <u>Offices and Agencies</u> – computer system upgrade equipment. Said improvements shall include all work, materials and appurtenances necessary and suitable therefor.

Section 2. The sum of \$105,000 is hereby appropriated to the payment of the cost of making the improvements described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be met from the proceeds of the sale of the bonds authorized and the down payment appropriated by this ordinance. Said improvements shall be made as general improvements and no part of the cost thereof shall be assessed against property specially benefited.

Section 3. It is hereby determined and stated that (1) said purpose is not a current expense of said Borough, and (2) it is necessary to finance said purpose by the issuance of obligations of said Borough pursuant to the Local Bond Law (Chapter 2 of Title 40A of the New Jersey Statutes Annotated, as amended; the "Local Bond Law"), and (3) the total estimated cost of said purpose is \$105,000, and (4) \$5,000 of said sum is to be provided by the down payment hereinafter appropriated to finance said purpose, and (5) the estimated maximum amount of bonds or notes necessary to be issued for said purpose is \$100,000, and (6) the cost of such purpose, as hereinbefore stated, includes the aggregate amount of \$5,000 which is estimated to be necessary to finance the cost of such purpose, including architect's fees, accounting, engineering and inspection costs, legal expenses and other expenses, including interest on such obligations to the extent permitted by Section 20 of the Local Bond Law.

Section 4. It is hereby determined and stated that moneys exceeding \$5,000, appropriated for down payments on capital improvements or for the capital improvement fund in budgets heretofore adopted for said Borough, are now available to finance said purpose. The sum of \$5,000 is hereby appropriated from such moneys to the payment of the cost of said purpose.



Section 5. To finance said purpose, bonds of said Borough of an aggregate principal amount not exceeding \$100,000 are hereby authorized to be issued pursuant to the Local Bond Law. Said bonds shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law. All matters with respect to said bonds not determined by this ordinance shall be determined by resolutions to be hereafter adopted.

Section 6. To finance said purpose, bond anticipation notes of said Borough of an aggregate principal amount not exceeding \$100,000 are hereby authorized to be issued pursuant to the Local Bond Law in anticipation of the issuance of said bonds. In the event that bonds are issued pursuant to this ordinance, the aggregate amount of notes hereby authorized to be issued shall be reduced by an amount equal to the principal amount of the bonds so issued. If the aggregate amount of outstanding bonds and notes issued pursuant to this ordinance shall at any time exceed the sum first mentioned in this section, the moneys raised by the issuance of said bonds shall, to not less than the amount of such excess, be applied to the payment of such notes then outstanding.

Section 7. Each bond anticipation note issued pursuant to this ordinance shall be dated on or about the date of its issuance and shall be payable not more than one year from its date, shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law and may be renewed from time to time pursuant to and within limitations prescribed by the Local Bond Law. Each of said bond anticipation notes shall be signed by the Mayor and by a financial officer and shall be under the seal of said Borough and attested by the Borough Clerk or Deputy Borough Clerk. Said officers are hereby authorized to execute said notes in such form as they may adopt in conformity with law. The power to determine any matters with respect to said notes not determined by this ordinance and also the power to sell said notes, is hereby delegated to the Chief Financial Officer who is hereby authorized to sell said notes either at one time or from time to time in the manner provided by law.

Section 8. It is hereby determined and declared that the period of usefulness of said purpose, according to its reasonable life, is a period of five years computed from the date of said bonds.

Section 9. It is hereby determined and stated that the Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the office of the Borough Clerk of said Borough, and that such statement so filed shows that the gross debt of said Borough, as defined in Section 43 of the Local Bond Law, is increased by this ordinance by \$100,000 and that the issuance of the bonds and notes authorized by this ordinance will be within all debt limitations prescribed by said Local Bond Law.

Section 10. Any funds received from private parties, the County of Bergen, the State of New Jersey or any of their agencies or any funds received from the United States of America or any of its agencies in aid of such purpose, shall be applied to the payment of the cost of such purpose, or, if bond anticipation notes have been issued, to the payment of the bond anticipation notes, and the amount of bonds authorized for such purpose shall be reduced accordingly.

Section 11. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

Section 12. The Borough intends to issue the bonds or notes to finance the cost of the improvements described in Section 1 of this bond ordinance. If the Borough incurs such costs prior to the issuance of the bonds or notes, the Borough hereby states its reasonable expectation to reimburse itself for such expenditures with the proceeds of such bonds or notes in the maximum principal amount of bonds or notes authorized by this bond ordinance.

Section 13. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this ordinance. Said obligations shall be direct, unlimited and general obligations of the Borough, and



the Borough shall levy <u>ad valorem</u> taxes upon all the taxable real property within the Borough for the payment of the principal of and interest on such bonds and notes, without limitation as to rate or amount.

Section 14. This ordinance shall take effect twenty days after the first publication thereof after final passage.

**ON THE QUESTION** – Councilman Hogan explained why he is voting no for our new viewers. It is an extension of our previous bond ordinance and wishes we would have known about this equipment when we did the first bond ordinance. He feels it doesn't make sense to have two different bond ordinances in the same fiscal year. It is not fiscally responsible.

# **MAYOR & COUNCIL REPORTS**

Council President McMorrow – the Preschool is back in session. The first day of school was September 6<sup>th</sup>. There are still openings in the 3 year old class. The floors have been redone in the bathrooms. Thank you to the DPW. They are having a carousel cake fundraiser. In October, the Fire Department will be visiting them, back to school night will be held, and a trip to Demarest Farms for pumpkin picking. The Police had 766 calls for the month of August. There were 5 arrests. On August 10<sup>th</sup> Chief Ostrow and Detective Sgt. Berghuys conducted a fraud presentation at the Senior Center. The transition from SwiftReach to the new RAVE SMART-911 system has been completed and is now active. Residents are encouraged to register on the new platform. The Borough's Emergency Operations Plan, which is mandated by the state and county, has been updated by Chief Ostrow, who serves as the Borough's emergency management coordinator. The plan has been reviewed and approved by the County and State officials and will remain in effect for two years. Chief Ostrow submitted all eligible expenses incurred by the Borough to FEMA which totaled a little over \$39,000 and was approved by FEMA. This amount will be reimbursed to the Borough in addition to Bergen County CARES relief that the Borough also received. Thank you to the Police Department who were fully present at Town Day and their help with the 911 memorial dedication. The Ambulance Corps responded to 28 calls for the month of August. They also participated in Town Day and will be at the high school football games. Ambulance Corps. still needs volunteers.

**Councilman Argiro** – Soccer is underway. Soccer generates the highest enrollment. Thank you to the coaches and parents. The fields look good. Thank you to the DPW. The major renovations at the Library have been completed. Thank you to Councilman Sokoloski for overseeing and guiding this project. Check out the Library's website for all activities. Thank you to everyone who helped at Town Day.

**Councilman Menafra** – Fire Department Line officers and in particular Lieutenant Witkowski have been working diligently to obtain grants. Fire Department was awarded a CSX grant of \$10,000 to purchase a UTV. FEMA safer grant was awarded for \$183,000 to assist with firefighter recruitment retention. Shout out to Chief Smithson and Lieutenant Witkowski for setting up and grilling at Town Day. Fire Department had 32 calls for the month of August. Fire Prevention did 24 inspections and 12 reinspections for the month of August. Northvale Board of Education had their meeting on August 24<sup>th</sup>. The start of the school year was not affected by the work being done. They are applying for a state grant for tutoring which targets students in 1<sup>st</sup> and 2<sup>nd</sup> grade who lost or fell behind during the pandemic. There has been ongoing classroom instruction and assessment adjustment based on the NJSLA testing results. The Principal filled an application to participate in Early Learning Network Improvement Community. The next meeting is September



21<sup>st</sup> at 6:30 PM. The Northern Valley Board of Education meeting was August 28<sup>th</sup>. Statistics were published for the Advanced Placement program. Eighty percent of students in these programs scored a 3 or better on the AP tests. There are over 300 students enrolled for at least 1 AP class. On July 5-8 there was an administrative retreat. Turf fields at both high schools were replaced at no cost since they were under warrantee. Next meeting is October 16th at 7:30 PM.

**Councilman Mattessich** – shout out to the DPW for the phenomenal job they did for Town Day and the 911 memorial. The DPW has been working on various jobs such as chipping, grass cutting, filling potholes, street signs, catchbasins. They installed new bathroom floors in the Preschool. They also had the streetsweeper out in Northvale and Rockleigh. He met with Michelle at the Senior Center. They picked up two new members at Town Day. The Crochet club sold a number of items at Town Day. There was a presentation on gambling today. On September 19<sup>th</sup> they are having a breakfast at 10:00 am. On September 21<sup>st</sup> Nurse Claudia Goez will be doing a presentation on senior wellness and still going strong. The Golden Age club was at the Beach Haven Surf Light Theater on September 7. They saw the play Grumpy Old Men and had lunch. On October 4<sup>th</sup> they will be going to Krucker's Octoberfest in Pomona.

**Councilman Hogan** – The Building Department issued 24 permits during the month of August and collected \$12,669 in fees. The year to date is \$96,271 which is way behind what was budgeted. Planning/Zoning Board had a meeting on August 16<sup>th</sup>. A resolution was approved for Richard Lee at 196 Bradley Avenue to install a deck and two previous meeting minutes were approved. Zoning board had a closed session which he could not attend as he is not a member. The meetings on September 6th and September 20th were cancelled due to lack of applications ready to be heard. Next scheduled meeting is October 4<sup>th</sup> at 7:30 pm. The Bergen County Utilities Authority will be having a shredding event on September 30<sup>th</sup>, 9:00-1:00 in Borough Hall parking lot. He would like to thank the following people for making Town Day a success: DPW, Fire Department, Police Department, Ambulance Corps, Iris Fallon, Kevin Trainor, Fr. Carlos, Maureen Felici, Fran Weston, the Mattessich family, Senator Schepisi, and Assemblyman Auth and all the vendors. Also everyone that donated time and money to make it a success. Everyone agrees it was a success. Woman's Club will be having their annual Beefsteak Dinner on October 20<sup>th,</sup> at 6:30 PM at the American Legion. Tickets for adults are \$55, kids are \$30. **Councilman Sokoloski** – The Board of Health had a quiet summer. The next meeting is October 19<sup>th</sup>. The Annual Free Rabies Clinic will be held on October 3<sup>rd</sup> at the DPW garage, 6:30-7:30 PM. He attended a zoom meeting with the Northern Valley Greenway. Over 500 letters were sent to the New Jersey Department of Transportation to try to qualify for funding. The State said there is no funding as yet. We have been very aggressive applying for grants. We have received over \$447,000 in grants, not including the Fire Department grants. It was wonderful to be at Town Day. We are a wonderful small town. Thank you to everyone for their kind thoughts and prayers. He is now cancer free and plans on sticking around for a long time.

Mayor McGuire – Town Day on Saturday was a very good time for everyone. Councilman Hogan did a nice job of thanking a lot of people. Thank you to Iris Fallon, our Events Coordinator and Kevin Trainor for a job very well done. Many months of work wereput into this. Thank you to the DPW, Chief Smithson, Fire Department, and our council members that helped cooking. Special thanks to Mrs. Felici who was on her feet for the whole time. Thank you to all sponsors that contributed, especially Inserra Shoprite. Thank you to Biddy O'Malley's and Brady's for donating the beer in the beer garden. A big special thank you to the DPW for the beautiful 911 memorial. Also thank you to Cleatus Farms and Hartman. We will be adding more to the 911 memorial, such as a plaque and lights. Cho Dae golf tournament was held on Monday. This is the first golf outing since 2019 when COVID hit. In 2024 it will be bigger and better. He attended a meeting on Monday night at Northern Valley Old Tappan High School welcoming staff and teachers in the Northern Valley district. The Superintendent, Principal, new teachers, and Mayor Kramer attended. The new Borough seal is on the wall behind the dais. Thank you to Council President McMorrow for obtaining this seal. There is another seal in the Senior Center. We are now live streaming on YouTube so smile for the camera. It will be archived on the YouTube site. We will publicize the link on social media and on our website. Need to discuss with the council



more in depth about the maintenance of the streetscape over the last few years. The ordinance states it is the responsibility of the business owner or resident to maintain the sidewalk, however this is not being done. We issue fines but there are still grass and weeds. We can ask the DPW to weed wack the area but it is not fair to the people who have been taking care of it. It is an eyesore to the town. We need to come up with a new ordinance. We should all think about this.

# **BOROUGH ATTORNEY REPORT**

Mr. Ferraro – the Mayor contacted him about the First Amendment Audits. He reached out to Mr. Barsa, our Risk Manager. A memo was issued with training involved on how to deal with people that come in and record and are aggressive. Mayor McGuire stated that the Municipal Clerk attended the training.

# **BOROUGH ENGINEER REPORT**

Mr. Loverich – the pole in front of Shoprite has been ordered. There is a four month lead time. The paving of Westcott Street should take place in the fall. We will be going out for bids for the Veterans Drive Phase II project in the fall. Construction will begin in 2024 due to Orange & Rockland's work. We will submit plans to the DOT and County to review for the Livingston Street Streetscape from Rockland to Eidner. Plans were approved for the Senior Center ADA doors and approved by the County. Next week we will go out for bid. The deadline is December.
