RESOLUTION #2023-176

TITLE: RESOLUTION APPROVING THE 2022 AUDIT

WHEREAS, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions; and

WHEREAS, the Annual Report of Audit for the year 2022 has been filed by a Registered Municipal Accountant with the Municipal Clerk as per the requirements of N.J.S. 40A:5-6, and a copy has been received by each member of the governing body; and

WHEREAS, the Local Finance Board of the State of New Jersey is authorized to prescribe reports pertaining to the local fiscal affairs, as per R. S. 52:27BB-34; and

WHEREAS, the Local Finance Board has promulgated a regulation requiring that the governing body of each municipality shall by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled:

General Comments Recommendations

and



WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled:

General Comments Recommendations

as evidenced by the group affidavit form of the governing body; and

WHEREAS, such resolution of certification shall be adopted by the governing body no later than forty-five days after the receipt of the annual audit, as per the regulations of the Local Finance Board; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board: and

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52 - to wit:

R.S. 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

NOW, THEREFORE BE IT RESOLVED, that the governing body of the Borough of Northvale hereby states that it has complied with the promulgation of the Local Finance Board of the State of New Jersey dated July 30, 1968 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

NOW, THEREFORE BE IT RESOLVED, that the Mayor and Council authorize Mayor Joseph McGuire to execute said agreement between the Borough of Northvale and the Borough of Paramus for Vehicle Maintenance and Repair by the Borough of Paramus.

ORDINANCE - 2nd READING

Mayor McGuire asked for a motion and second for the second reading of Ordinance #1075-2023. Motion was made by Councilman Mattessich, seconded by Councilman Menafra.

ORDINANCE #1075-2023

BOND ORDINANCE TO AUTHORIZE THE UNDERTAKING OF THE LIVINGSTON STREET STREETSCAPE IMPROVEMENTS PROJECT (EAST SIDE OF LIVINGSTON STREET - FROM ROCKLAND AVENUE TO EIDNER WAY) IN, BY AND FOR THE BOROUGH OF NORTHVALE, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$420,000 TO PAY THE COST THEREOF, TO APPROPRIATE A STATE GRANT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BOND



BE IT ORDAINED, by the Borough Council of the Borough of Northvale, in the County of Bergen, New Jersey, as follows:

Section 1. The Borough of Northvale, in the County of Bergen, New Jersey (the "Borough"), is hereby authorized to undertake the Livingston Street Streetscape Improvements Project (east side of Livingston Street - from Rockland Avenue to Eidner Way) in, by and for the Borough. Said improvements shall include all work, materials and appurtenances necessary and suitable therefor.

Section 2. The sum of \$420,000 is hereby appropriated to the payment of the cost of making the improvements described in Section 1 hereof. Said sum so appropriated shall be met from the proceeds of the sale of the bonds authorized and the State grant appropriated by this ordinance. No down payment is required pursuant to the provisions of N.J.S.A. 40A:2-11(c) because this ordinance involves a project to be funded by a State grant. Said improvements shall be made as general improvements and no part of the cost thereof shall be assessed against property specially benefitted.

Section 3. It is hereby determined and stated that (1) the making of such improvements (hereinafter referred to as "purpose") is not a current expense of the Borough, and (2) it is necessary to finance said purpose by the issuance of obligations of the Borough pursuant to the Local Bond Law (Chapter 2 of Title 40A of the New Jersey Statutes Annotated, as amended; the "Local Bond Law"), and (3) the estimated cost of said purpose is \$420,000, and (4) \$330,000 of said sum is to be provided by the State grant hereinafter appropriated to finance said purpose, and (5) the estimated maximum amount of bonds or notes necessary to be issued for said purpose is \$90,000, and (6) the cost of said purpose, as hereinbefore stated, includes the aggregate amount of \$70,000, which is estimated to be necessary to finance the cost of said purpose, including architect's fees, accounting, engineering and inspection costs, legal expenses and other expenses, including interest on such obligations to the extent permitted by Section 20 of the Local Bond Law.

Section 4. It is hereby determined and stated that the sum of \$330,000 received or to be received as a grant from the State of New Jersey Department of Transportation is hereby appropriated to the payment of the cost of such purpose.

Section 5. To finance said purpose, bonds of the Borough of an aggregate principal amount not exceeding \$90,000 are hereby authorized to be issued pursuant to the Local Bond Law. Said bonds shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law. All matters with respect to said bonds not determined by this ordinance shall be determined by resolutions to be hereafter adopted.

Section 6. To finance said purpose, bond anticipation notes of the Borough of an aggregate principal amount not exceeding \$90,000 are hereby authorized to be issued pursuant to the Local Bond Law in anticipation of the issuance of said bonds. In the event that bonds are issued pursuant to this ordinance, the aggregate amount of notes hereby authorized to be issued shall be reduced by an amount equal to the principal amount of the bonds so issued. If the aggregate amount of outstanding bonds and notes issued pursuant to this ordinance shall at any time exceed the sum first mentioned in this section, the moneys raised by the issuance of said bonds shall, to not less than the amount of such excess, be applied to the payment of such notes then outstanding.

Section 7. Each bond anticipation note issued pursuant to this ordinance shall be dated on or about the date of its issuance, shall be payable not more than one year from its date, shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law, and may be renewed from time to time pursuant to and within limitations prescribed by the Local Bond Law. Each of said notes shall be signed by the Mayor and by a financial officer and shall be under the seal of the Borough and attested by the Borough Clerk or Deputy Borough Clerk. Said officers are hereby authorized to execute said notes and to issue said notes in such form as they may adopt in conformity with law. The power to determine any matters with respect to said notes not determined by this ordinance, and also the power to sell said notes, is hereby delegated to the Chief Financial Officer who is hereby authorized to sell said notes either at one time or from time to time in the manner provided by law.



Section 8. It is hereby determined and declared that the period of usefulness of said purpose, according to its reasonable life, is a period of ten years computed from the date of said bonds.

Section 9. It is hereby determined and stated that the Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the office of the Borough Clerk of the Borough, and that such statement so filed shows that the gross debt of the Borough, as defined in Section 43 of the Local Bond Law, is increased by this ordinance by \$90,000 and that the issuance of the bonds and notes authorized by this ordinance will be within all debt limitations prescribed by the Local Bond Law.

Section 10. Any funds received from private parties, the County of Bergen, the State of New Jersey or any of their agencies or any funds received from the United States of America or any of its agencies in aid of said purpose (other than the State grant hereinbefore appropriated, which shall be applied to the cost of said purpose but shall not be applied to the payment of outstanding bond anticipation notes and the reduction of the amount of bonds authorized), shall be applied to the payment of the cost of said purpose, or, if bond anticipation notes have been issued, to the payment of the bond anticipation notes, and the amount of bonds authorized for said purpose shall be reduced accordingly.

Section 11. The Borough intends to issue bonds or notes to finance the cost of the improvements described in Section 1 of this bond ordinance. If the Borough incurs such costs prior to the issuance of such bonds or notes, the Borough hereby states its reasonable expectation to reimburse itself for such expenditures with the proceeds of such bonds or notes in the maximum principal amount of bonds or notes authorized by this bond ordinance.

Section 12. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and interest on the obligations authorized by this ordinance. Said obligations shall be direct, unlimited and general obligations of the Borough, and the Borough shall levy <u>ad valorem</u> taxes upon all the taxable real property within the Borough for the payment of the principal of and interest on such bonds and notes, without limitation as to rate or amount.

Section 13. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

Section 14. This ordinance shall take effect twenty days after the first publication thereof after final passage.

MAYOR & COUNCIL REPORTS

Council President McMorrow – thank you to the Preschool, Police, and Ambulance Corps for their participation in the tree lighting. The 2024-2025 preschool registration will open next week. Police had 561 events in the month of November. There were 105 traffic stops, 91 selective traffic enforcement details, 19 mother vehicle crashes, and 48 medical assist calls. The installation of the Hogan Park surveillance cameras will begin this week. The Ambulance Corps. had 21 calls for the month of November. They are in desperate need of volunteers.



Councilman Argiro – indoor soccer and basketball will be starting very soon. There is a meeting tonight at the Library. Check out the Library website for upcoming events.

Councilman Menafra – shout out to the Fire Department for their participation in the Northvale and St. Anthony tree lightings. Fire Department had 29 calls for the month of November. Fire Prevention had 24 inspections and 4 reinspections for the month of November. Municipal Alliance submitted a budget modification to the County and are waiting for their reply. If approved, it would provide grant funding for two programs: Too Smart To Start and Don't Get Beeped In which are related to alcohol and substance abuse and Get Connected, a three session program targeted for seniors at the Senior Center. Northvale Board of Education had a meeting on November 21st. The Annex is complete and furniture has been ordered and the Preschool should be ready to start for the 2024/2025 school year. Registration for the Preschool is open. Basketball is underway. The PTO Holiday breakfast was held on December 9th. The next Board of Education meeting is scheduled for December 14th at 6:30 in the Media Center. The Northern Valley Board of Education had two meetings since our last council meeting. The Superintendent mentioned there were 55 commended students and one semi finalist for the national merit scholarship. There was a college counseling presentation for the students. There was a special education presentation. The NVOT marching band won the group 3 state championship. Next meeting is in January with a date to be determined.

Councilman Mattessich – the DPW concluded leaf pick up, still picking up brush, did prep work for the tree lighting, prepping the trucks for snow plowing. There was a sewer issue on Veterans Drive. Bruce Hammer gave a Pearl Harbor presentation on December 7th at the Senior Center. On December 14th there will be an Alliance For Senior Services presentation. The Senior Center Christmas luncheon will be held on December 21st. Golden Age Christmas party is happening now. Membership will close February 8th.

Councilman Sokoloski – most committees have been inactive. The Board of Health Reorganization meeting is scheduled for January 9th. Northern Valley Greenway meeting was cancelled. Grant applications still pending \$2,409,066. Grant application for a new DPW building for approximately \$541,920 will be submitted by December 15th. We have been awarded \$890,486 in 2023. Met with Scott, Mayor McGuire, and the architect to review the grant received for \$65,000 for upgrades and ADA improvements to Senior Center bathrooms. This work will be for the Spring.

Mayor McGuire – the Reorganization meeting will be January 3, 2024 at 6:30 pm. Thank you to everyone that helped with the tree lighting – Iris Fallon, Kevin Trainor, DPW, Police, Fire, and Ambulance. It was a really great effort by everyone. The camera installation will begin at Hogan Park very shortly. Our 1st annual light decorating contest for the houses in Northvale have a good amount of people signed up. The deadline is Friday. Judging will take place next week. Some good news – we have been accepting leaves from Westwood every year for the past few years through shared service agreement. In the past we received 3100 cubic yards of leaves. They are sending us compressed leaves. It is about 2.65 times higher than what they are sending us. This year we will be receiving about 8,000 cubic yards of leaves from them which is much higher than we anticipated. In our budget this year we had anticipated about \$30,000-\$34,000. We should be receiving about \$90,000. This morning I attended a film ready New Jersey meeting at Bergen County headquarters. New Jersey film industry is growing considerably. Companies are leaving southern California and looking for alternatives. There is a program we will pursue in 2024 to be film ready. You have to be film ready certified, pass an ordinance for production companies when they come here, permit fees, database of locations available. They are looking for locations to film. A film liaison person will be designated. This will generate revenue. The recycling calendars will be going out next week or so. The Q4 newsletter is being mailed next week. The indoor pickleball opening is Saturday on Legrand Avenue, there are only 3 in Bergen County. An indoor basketball shooting zone also opened on Legrand Avenue. A hockey training facility is looking to build next to the old Boston Market.

Mr. Loverich – had the Veterans Drive precon meeting on December 11^{th.} Work should begin in the spring/summer after O&R finishes their project. Livingston Street Streetscape – met with residents along impacted area. Two residents were satisfied with the project. Received approval from Bergen County Soil Conservation and Bergen Count Engineering had no comments on the project. Should be going out to bid in early January with construction beginning in early Spring. The Senior Center ADA doors will be delivered by January 4th and will mobilize on January 8th to begin installation. The county is good with the schedule. Neglia will be submitting a proposal in January for the Senior Center ADA bathrooms.
