# **RESOLUTION #2023-174**

# TITLE: RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT FOR PROFESSIONAL ACCOUNTING SERVICES

WHEREAS, the Borough of Northvale is in need of accounting services in order to provide such services as bank reconciliations, transaction posting, and general ledger maintenance, and

**WHEREAS**, Battaglia Associates LLC ("Battaglia") located at 490 Ridgefield Terrace, Fairview, New Jersey is qualified to offer these services to the Borough; and

WHEREAS, these services will be provided by Battaglia as an independent contractor; and

WHEREAS, the services provided are professional in nature and not subject to competitive bidding; and

**WHEREAS,** the cost of these services will not exceed the sum of \$29,000 per year, and are proposed at \$2,000 per month, with an initial set up fee and reconciliation through October 2023 of \$5,000; and



WHEREAS, these services will result in savings and greater efficiency to the Borough.

NOW, THEREFORE BE IT RESOLVED, by the Governing Body of the Borough of Northvale that the Mayor is hereby authorized to enter into a contract with Battaglia for the services as set forth above.
