TITLE: RESOLUTION AUTHORIZING SUBMISSION OF A GRANT APPLICATION TO THE NEW JERSEY DEPARTMENT OF COMMUNITY AFFAIRS' RESILIENT COMMUNITIES PROGRAM

MOTION SECOND

WHEREAS, the New Jersey Department of Community Affairs has made grant funding available via the Resilient Communities Program; and

WHEREAS, the Mayor and Council of the Borough of Northvale desires to apply for and obtain a grant from the New Jersey Department of Community Affairs for approximately \$583,920.00 to carry out a project to provide the Northvale Department of Public Works with a garage to house DPW vehicles and equipment; and

WHEREAS, on December 1, 2023, the Borough of Northvale held a public hearing regarding the submission of the Grant Application; and

WHEREAS, the Borough of Northvale believes it is in the best interests of the Borough to apply for the said Grant.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Northvale:

1. Hereby authorize the application for such a grant; and,
2. Recognizes and accepts that the Department may offer a lesser or greater amount and therefore, upon receipt of the grant agreement from the New Jersey Department of Community Affairs, does further authorize the execution of any such grant agreement; and also, upon receipt of the fully executed agreement from the



Department, does further authorize the expenditure of funds pursuant to the terms of the agreement between the Borough of Northvale and the New Jersey Department of Community Affairs.

BE IT FURTHER RESOLVED, that the persons whose names, titles, and signatures appear below are authorized to sign the application, and that they or their successors in said titles are authorized to sign the agreement, and any other documents necessary in connection therewith.
