# APPLICATION OF SCOTT & DAWN FURLETTI 509 WEST AVENUE BLOCK 708 LOT 2

Scott Furletti came forward on his own behalf to provide testimony to the Board regarding his application for variance relief. Standing with Mr. Furletti was co-applicant, Dawn Furletti as well as the applicant's architect, Robert Zaccone.

Mr. Furletti was sworn in by Attorney Paster and thereafter explained the specifics of the variance he was seeking. Once Mr. Furletti provided his testimony, Chairman Amorosso asked Mr. Furletti to confirm the variance being requested was for 3 feet but lessened in size as the addition goes down the property line, having the house be squared off.

Chairman Amorosso asked the Board members if they had any questions. Mr. Moran asked about the property being listed as a mother/daughter house and if there was intention to wall it off and be used as a rental since this was a sizable addition. Mr. Furletti confirmed this was not the intention and referred to the agreement back when this home was to be a mother/daughter, which was the house not being sold as a mother/daughter when the Furletti's choose to sell.

Next, the applicants architect came forward to provide testimony on behalf of the proposed project. Attorney Paster swore in Robert Zaccone. Mr. Zaccone provided confirmation of his license being in good standing and included his credentials to be qualified to provide testimony. Mr. Zaccone proceeded to go through the plans he prepared for the project. Mr. Moran asked for further details about the plans which Mr. Zaccone answered. Nick Chelius, of Colliers asked for further details regarding the covered patio which Mr. Zaccone explained. Mr. Sillery asked why the applicant did not want to make the addition smaller to stay within the setback limits which Mr. Furletti addressed.
