## TITLE: RESOLUTION APPROVING THE 2021 AUDIT

**WHEREAS**, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions; and

**WHEREAS,** the Annual Report of Audit for the year 2021 has been filed by a Registered Municipal Accountant with the Borough Clerk as per the requirements of N.J.S. 40A:5-6, and a copy has been received by each member of the governing body; and

**WHEREAS**, the Local Finance Board of the State of New Jersey is authorized to prescribe reports pertaining to the local fiscal affairs, as per R. S. 52:27BB-34; and

**WHEREAS,** the Local Finance Board has promulgated a regulation requiring that the governing body of each municipality shall by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled:

General Comments Recommendations

and

**WHEREAS,** the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled:

General Comments Recommendations

as evidenced by the group affidavit form of the governing body; and

**WHEREAS,** such resolution of certification shall be adopted by the governing body no later than forty-five days after the receipt of the annual audit, as per the regulations of the Local Finance Board; and

**WHEREAS,** all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

**WHEREAS,** failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52 - to wit:

R.S. 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

**NOW, THEREFORE BE IT RESOLVED**, that the governing body of the Borough of Northvale hereby states that it has complied with the promulgation of the Local Finance Board of the State of New Jersey dated July 30, 1968 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

# TITLE: RESOLUTION AWARDING BID FOR NJDOT FY2021 MUNICIPAL AID PROGRAM – CLINTON AVENUE ROADWAY PROJECT

**WHEREAS**, the Borough of Northvale, upon advertisement and pursuant to specifications, solicited bid proposals for the NJDOT FY2021 Municipal Aid Program – Clinton Avenue Roadway Project (the "Project"); and

WHEREAS, the Project consists of roadway improvements along Clinton Avenue (from Wildwood Road West to Briarwood Lane and from east of CSX right-of-way to Tappan Road) and Arrow Street (from Hughes Street to Wildwood Road West). The work includes HMA milling and paving, full depth pavement repair, installation of ADA-compliant curb ramps, upgrading inlets with eco curb pieces and bicycle safe grates, traffic striping, signage upgrades, cleaning and video inspection of sanitary sewer pipes, and sanitary sewer repairs; and

**WHEREAS**, four (4) bid proposals were received from D&L Paving Contractors, Inc., DLS Contracting Inc., Your Way Construction Inc. and American Asphalt & Trucking LLC on September 22, 2022, the date set forth in the invitation for receipt of bid proposals from; and

**WHEREAS,** the two lowest bids, American Asphalt & Trucking LLC and DLS Contracting Inc. are rejected for failure to submit a complete list of all sub-contractors which was identified as mandatory information required by the bid specifications; and

**WHEREAS,** D&L Paving Contractors, Inc. was the third lowest bid providing a Base Bid of \$307,364.57, \$28,368.00 for Alternate Bid "A" comprising a total Bid amount of \$335,732.57 along with all mandatory information as required in the bid specifications was provided; and

**WHEREAS**, on the basis of the foregoing, the Borough Engineer has recommended the contract for the Project be awarded to D&L Paving Contractors, Inc. as the third lowest bidder.

**NOW, THEREFORE BE IT RESOLVED,** by the Governing Body of the Borough of Northvale that the bid proposal submitted by D&L Paving Contractors, Inc. in the amount of Base Bid of \$307,364.57, \$28,368.00 for Alternate Bid "A" comprising a total Bid amount of \$335,732.57 shall be and is hereby accepted and the contract for the NJDOT FY2021 Municipal Aid Program – Clinton Avenue Roadway Project shall be awarded to D&L Paving Contractors, Inc.

TITLE: RESOLUTION AUTHORIZING OFFER TO RESOLVE CLAIM FOR SERVICES AND/OR REIMBURSEMENT BY PARIS SQUARE HOMEOWNERS' ASSOCIATION

WHEREAS, on September 6, 2006, the Northvale Planning Board/Zoning Board (the "Board") adopted Resolution 06-13, granting approval to Rio Vista Homes at Northvale, LLC ("Rio Vista" or "Developer") to construct an 88 unit multi-family development called Rio Vista on the subject lots. Since 2006, nine (9) resolutions involving the Subject Property have been adopted, all of which are incorporated herein by reference.; and

**WHEREAS,** dominion and control of the said housing development was transferred from the Developer, to a private homeowners association, known and referred to as the Paris Square Homeowners' Association, Inc., (hereinafter 'Paris Square' or 'Association') or a similar name; and

**WHEREAS**, the Borough was provided notice of the transfer of administration and control of the development by letter dated July 2, 2021 from John Pandolfo, as managing agent for and on behalf of the said Association, so notifying the Borough and requesting services and/or reimbursement pursuant to the New Jersey Municipal Services Act, N.J.S.A. 40:67-23.3, et seq.; and

**WHEREAS**, the Borough has acknowledged an obligation to provide the services at issue or to reimburse the Association for same, dating back to at least 2014; and

**WHEREAS,** the Association has acknowledged that no reimbursement is due for garbage and recycling collection as those services have been provided under the Borough's municipal solid waste and recycling contracts throughout the operative timeframe; and

**WHEREAS,** based upon available information, the Borough's per household cost for street lighting in the relevant time period is approximately:

**WHEREAS**, the Borough now seeks to resolve the claims by the Association and to uphold and fulfill its responsibilities and obligations to all residents by providing essential services required by statute and case law, and other good cause appearing.

**NOW, THEREFORE BE IT RESOLVED,** by the Council of the Borough of Northvale, County of Bergen, State of New Jersey that the Borough Attorney is authorized to offer a settlement of all claims and issues for reimbursement advanced by Bellaire in an amount not to exceed a total of Twenty Two Thousand Eight Hundred Eighteen and 00/100 (\$22,818.00) Dollars, and to thereafter provide such services or reimbursement consistent with the settlement agreement, and the Mayor and Borough Clerk be and are hereby authorized to execute such documents as may be necessary to memorialize such an agreement in a form and substance acceptable to the Borough Attorney, subject to certification of available funds by the Chief Financial Officer, to be presented in the usual course of business; and

**BE IT FURTHER RESOLVED,** that a certified copy of this resolution shall be sent immediately upon the entry hereof to the CFO, counsel for the Association and all departments, vendors and agencies necessary to provide the required services.
